Who are we?

Over the past decade, the European Institute of Innovation and Technology (EIT) established nine Knowledge and Innovation Communities (KICs) to strengthen Europe's capacity to innovate and solve global societal challenges.

In 2018, acknowledging the importance of international cooperation in tackling such challenges, the EIT and its KICs established the **EIT Global Outreach** Programme. Contributing to the EU's Global Approach to Research & Innovation, it is the first EIT Community coordinated effort at the global level. The EIT Global Outreach programme bridges the EIT's innovation ecosystem with those of outreach locations, forging synergies with global innovation leaders. EIT Health, EIT Climate-KIC, EIT Manufacturing, EIT Digital, EIT Culture & Creativity, and EIT Food currently lead the EIT Global Outreach initiative.

The **EIT Global Platform** is A unique platform for European innovation actors to explore global ecosystems and gain access to best practices and know-how. In a rapidly changing world and a fast-paced global market, we want to give a real-time response. 

Why should I apply?

Who should apply?

The ideal participant is an experienced European senior professional at the management/decision-making level in an organization boosting European startup growth, significantly impacting the European ecosystem. The participant should deal with **innovation** or **business creation**, with at least **five years** of relevant professional experience from at least one of the following sectors: industry, academia, and government. As such, they should be able to contribute knowledge, expertise, and network to the programme and provide added value to their peers.

For example, heads of accelerators, VCs, innovation agencies, labs, incubators, or other business creation activities from academia, industry, government, and TTOs.

The programme is <u>not suited</u> for individual startups or consultants.

Eligible applicants are divided into four categories:

- 1. **EIT KIC Partners**³ and KIC cooperating entities under the EIT Regional Innovation Scheme (RIS) from the six KICs involved in the Global Outreach cluster: EIT Health, EIT Climate- KIC, EIT Manufacturing, EIT Digital, EIT Food, and EIT Culture & Creativity.
- 2. **EIT KIC Staff** from the 6 KICs involved in the Global Outreach cluster: EIT Health, EIT Climate- KIC, EIT Manufacturing, EIT Digital, EIT Food, and EIT Culture & Creativity.
- 3. Partner/staff from other KICs EIT InnoEnergy, EIT RawMaterials, and EIT Urban Mobility

4. Ecosystem Managers, non-EIT Partners

Assessment Process

Each application will be reviewed and ranked by the following criteria:

- Impact of your organization and programme on the European Innovation ecosystem (i.e., number of startups you meet weekly) 50% of the score
- Professional role and seniority level 30% of the score
- Motivation and added value to the programme 20% of the score
- An individual online interview might be scheduled as an additional evaluation criterion.
- The selection will be competitive and based on excellence and the above criteria. The
 final selection will be made by the EIT Global Outreach (with members representing
 the 6 KICs: EIT Health, EIT Climate- KIC, and EIT Manufacturing, EIT Food, EIT Digital,
 and EIT Culture & Creativity).

The total cost of the programme is 6,000 EUR; however, EIT Global Outreach can offer <u>partial funding</u> of the programmes and/or <u>Travel & Accommodation reimbursement</u> based on the following categories:

Cultural Immersion to Tokyo – Day 0 (23.6.2024)


Begin your journey with a cultural immersion into the human, cultural, and geographical landscape of Tokyo, gaining an understanding of what stands the foundation of this ecosystem.

During the workshop, participants will:


- Present Ecosystem Challenges


- Does the programme require me to attend the week in Tokyo physically?
 Yes, participation in Tokyo is required, and the core Connect & Experience event
 provides you with professional training and builds the community. You will have the
 chance to travel around the city, meet Japanese peers, and learn from one of the
 world's leading innovation ecosystems.
- Who will we meet during the programme?

 The color of the programme and the programme are the programme.

The cohort will be comprised of ecosystem leaders from all over Europe that were carefully selected to join the programme. You will meet peers and ecosystem leaders from Tokyo and Japan, top speakers and lecturers on several topics, executives from global companies active in Tokyo, and many more.

Who is considered an ecosystem leader?

An ecosystem leader is an experienced senior professional at the management/decision-making level in an organization boosting European start-up





growth, significantly impacting the European ecosystem. They should deal with innovation or business creation in any of the following sectors: industry, academia, and government. For example, VCs, TTOs, heads of accelerators, innovation agencies, labs, incubators, or other business creation activities from academia, industry, and government.

What topics will be covered during the bootcamp in Tokyo?

The programme encompasses various subjects, including an overview of the Tokyo ecosystem and meetings with leading figures from the industry. You will have the chance to get your hands 'dirty' and delve into an ecosystem-building workshop, learn the dos and don'ts of branding, visit academia and governmental offices, meet with VCs, and become inspired by the many opportunities that will expose themselves.

How much does the programme cost?

The applicants will be ranked according to the criteria noted here, and the Global Outreach steering committee will make the final decision as to the participants. Applicants will receive responses by 9th May 2024.

This financial support agreement, hereinafter the "Agreement", shall have an effect as of [1 June 2024] and is entered into by and between:

Hereinafter, jointly or individually, referred to as "Parties" or "Party";

WHEREAS:

InnoStars has set up a project, being the project Connect and Experience Japan, hereinafter referred to as the "**Project**".

The Recipient will be involved in the Project and will receive financial support from InnoStars

In this Agreement the Parties wish to lay down the contractual arrangements between them regarding the implementation of the Project and the financial support, transposing to the extent needed the provisions of the binding agreements that InnoStars has entered into with the EIT and EIT Health e.V.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

Article 1: Definitions

1.1 Definitions

"Effective Date" shall mean the date first referenced above.

"EIT" or **"granting authority"** shall mean the European Institute of Innovation and Technology, currently regulated by Regulation (EU) 2021/819 of the European Parliament and of the Council of May 20, 2021 (**"EIT Regulation"**).

"Project" shall mean the participation of the Recipient in the Project Connect and Experience Japan.



Article 2: Purpose

The purpose of this Agreement is to lay down the contractual arrangements between the Parties regarding the implementation of the Project and the financial support provided by InnoStars

Article 3: Entry into force, duration, and termination

3.1 Entry into force and duration

This Agreement shall have effect from the Effective Date and shall apply until the end date of the Project. The expected end date of the Project is 31.12.2023.

However, this Agreement may be terminated in accordance with Article 3.2 of this Agreement.

3.2 Termination

3.2.1. In the event that the Recipient is in breach of its obligations under this Agreement, InnoStars may give formal notice to the Recipient requiring that such breach will be remedied within 14 calendar days of this formal notice, unless such breach cannot be remedied.

If such breach is substantial and is not remedied within that period or, is not capable of remedy, InnoStars may terminate this Agreement upon notice

3.2.2. InnoStars may terminate this Agreement with immediate effect through written notice to the Recipient in the event the further implementation of the Project is prevented or delayed with more than two weeks by Force Majeure.

3.3 Effects of termination

Termination shall not affect the obligation of the Recipient to provide all input, deliverables, and documents for the period that the Agreement was still in force and effect.

Article 4: Implementation of the Project

The Recipient must take part in the efficient implementation of the Project and cooperate, perform and fulfil, promptly and on time, all of its obligations under this Agreement

Article 5: Reporting

The Recipient shall comply with any reporting requirement of InnoStars in a timely manner. The Travel and Accommodation Support Report (Annex 3) must be submitted no later than 30 days after the Tokyo visit (July 27 2024). Reports that are submitted after the deadline will not be eligible for reimbursement.

Article 6: Financial provisions

6.1. Financial contribution

The Recipient shall receive a financial contribution to cover actual costs related to travel and accommodation. The Recipient shall receive financial contribution only for its tasks in the Project carried out. The Recipient shall receive a financial contribution for its travel and accommodation costs incurred in relation to the Connect and Experience Japan programme - to the Tokyo delegation

The maximum amount of financial contribution to the Recipient under this Agreement is in total **2,600 EUR (All eligible costs described in annex 2)**



6.2 Payment Schedule

The payment will be awarded as follows:


The financial support granted to the Recipient is provided within 30 days after submission and acceptance of the Travel and Accommodation Support Report.

If the Agreement is terminated before the completion of the Project, the Recipient shall refund all payments it has received except the amount corresponding to the costs already incurred and accepted by InnoStars.

6.3 Payments

Payment by InnoStars to the Recipient hereunder, shall be made to the following bank account:

or any other bank account details as may be provided by the Recipient to Innostars after the execution of this Agreement, which new details shall only be effective five working days after receipt by InnoStars of written notice from Recipient in that respect.

Payments will be made from any of InnoStars' registered bank accounts.. Any recoveries shall be made to this bank account.

Article 7: Co-branding and communication

The Recipient shall take into account and respect any co-branding and communication guidelines requested by InnoStars.

Article 8: Liability towards each other

8.1 Limitations of contractual liability

No Party shall be responsible to the other Party for any indirect or consequential loss or similar damage such as, but not limited to, loss of profit, loss of revenue or loss of contracts, provided such damage was not caused by a wilful act, gross negligence or by a breach of confidentiality.

8.2 Damage caused to third parties

Each Party shall be solely liable for any loss, damage or injury to third parties resulting from the performance of the said Party's obligations by it or on its behalf under this Agreement.

8.3 Force Majeure

No Party shall be considered to be in breach of the Agreement if it is prevented from fulfilling its obligations under the Agreement by Force Majeure.

Each Party will notify the other Party of any Force Majeure without undue delay.



Article 9: Confidentiality

The Parties must keep confidential any data, documents or other material (in any form) that is identified as confidential or sensitive ("Confidential" Information)

Unless otherwise agreed between the Parties, they may use Confidential Information only to implement this Agreement.

Article 10: Miscellaneous

10.1 Applicable law

This Agreement shall be construed in accordance with and governed by the laws of Belgium.

The Parties shall endeavour to settle their disputes amicably.

All disputes arising out of or in connection with this Agreement, which cannot be solved amicably, shall be finally settled before the courts of Brussels.

10.2 Data Protection

The Recipient ensures that any processing of personal data shall be performed in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

The collected personal data will be used solely for the implementation, follow-up, reporting and management of this Agreement by the Recipient and its subsidiaries and for dissemination of information and communication purposes foreseen for this Agreement. Data subjects have the right to access, rectify or delete their personal data. Data subjects can also object to its processing. To exercise these rights, data subjects can contact Recipient.

Article 11: Rights under EIT agreements

The Recipient acknowledges and agrees that InnoStars must be able to comply with its obligations under the binding agreements it has entered into with EIT Health e.V (including the so-called Internal Agreement and the Financial Support Agreement) and therefore Recipient agrees to provide, when relevant, the rights necessary to InnoStars to ensure compliance, a.o regarding auditing.



ANNEX 2 – Eligible costs

The following expenditures are eligible under the current agreement:

- Round-trip flights to New York (from Europe or Horizon Europe associated countries) economy class **only**
- Travel by taxi only allowed to and from the airport, but as an alternative, you are encouraged to use train or bus as well on this route. During the program, we reimburse you for 1 Tokyo Metro pass
- Accommodation in Tokyo City.

Accommodation is a pre-booked group reservation, please get in contact with our Travel Manager, Petra Bán (petra.ban@eithealth.eu). The group reservation costs EUR XXX/4 nights in xxx hotel, she is holding the rooms already. The recipient must calculate the available budget based on this amount and look for a flight to be within budget.
